
## **DOES INFLATION HAVE A SHELF LIFE?**

M&A deal volume remained strong in Q4 2021 with **75 transactions** taking place within our Team's tracked Food & Beverage sectors. Active acquirers in the Food & Beverage industry targeted well-positioned businesses with demonstrated ability to pass on price increases while maintaining, and in some cases growing, sales volumes. Inflationary pressures sat top of mind among industry participants and everyday consumers; **headline inflation rose 7% over the last twelve months**<sup>1</sup> **and may have room to run**. Inflation continues to place downward pressure on the industry's bottom line with rising costs prevalent across commodity, production, packaging, transportation and labor inputs.

The food at home index, tracked by the Bureau of Labor Statistics, rose 6.5% over the last 12 months; this compares to a 1.5% annual increase over the last 10 years<sup>1</sup>. Supply-side constraints, rooted in global port congestion and raw material availability, accelerated price increases across everyday items, such as:

- meats, poultry, fish and eggs;
- dairy and related products; and
- nonalcoholic beverages and beverage materials; among other categories.






Nominal U.S. grocery store and retail and food service sales increased 8.16% and 16.95%, respectively from December 2020 to December 2021<sup>2</sup>. While retail and food service sales increased at a greater clip during the period than its grocery store counterpart, the sector's base was measured at a time (December 2020) when COVID-induced restrictions on indoor dining were more prevalent than today's operating environment. This is in comparison to grocery store sales, which notched record growth in 2020 as consumers swapped away-from-home dining for at-home options. Grocery stores demonstrated, as expected, strong ability to pass on input price increases to its shoppers during the period—we expect grocery store consolidation to continue in early 2022.

## Significant Transactions Occurring in Q4 2021

#### Hershey Acquires Fastest Growing U.S. Pretzel Brand, Acquires Contract Manufacturer in Tandem







Hershey acquired Dot's Pretzels in December 2021, expanding its snacking portfolio filled with popular household staples, including *Skinny Pop, Pirate's Booty* and *Paqui*, among others. The addition of Dot's Pretzels accelerates Hershey's vision by adding to its portfolio the fastest-growing scale U.S. pretzel brand, representing 55 percent<sup>1</sup> of the pretzel category's growth during the past year.

Pretzels, Inc. served as contract manufacturer to Dot's Pretzels prior to the transaction. Hershey acquired Pretzels, Inc. in tandem to bring manufacturing competencies in-house to further support Dot's Pretzels' and Hershey's salty snacks portfolio's future growth.

#### New Belgium Brewing Acquires Michigan's Second Largest Craft Beer Producer

New Belgium Brewing acquired Bell's in November 2021, combining two Michigan-based beer producers. Bell's is expected to contribute over 500 employees<sup>2</sup>, annual production capacity of roughly 500,000 barrels<sup>2</sup> and several well-known recipes to the transaction. The combined entity boasts popular beer labels, including *Voodoo Ranger, Fat Tire* and *Oberon Ale*, among others.

Bell's is expected to add north of \$100 million to New Belgium's top -line financials, generating nearly \$90 million in revenue as of early October 2021, according to IRI.

#### Coca-Cola Acquires Fastest Growing Beverage Company





Coca-Cola initially purchased 15% of BODYARMOR in 2018 and acquired the remaining 85% for \$5.6 billion in cash in November 2021<sup>3</sup>. The initial minority investment unlocked BODYARMOR access to the Coca-Cola bottling system, contributing to the company's consistent 50% growth rate.

BODYARMOR's key management members are expected to remain on board through 2022 to support the transition process and execute the company's strategic vision. The acquisition will allow Coca-Cola and BODYARMOR personnel to collaborate on Coca-Cola's still beverages portfolio, including marketing, packaging and innovation strategies across multiple brands<sup>3</sup>.
